Whiteside School District 115 Transition Plan/Phases

Proposed start date for Phase 1: 9/16/2020

Phase 1

Full Remote with Limited In-Person: All students will be remote except select special education classrooms and early childhood. Classrooms at the middle school include: Ms. Harwell and Mrs. Pruett and at the elementary school: Ms. Fagan (EC), Ms. Murphy (EC), Ms. Nelson, Mrs. Petty, and Mrs. Hartung. These students will be attending 2.5 hours per day 4 days a week during the transition back to learning. Remote learning in these classrooms will be shifted to the afternoon.

- *Early Childhood will begin on 9/17/2020 due to scheduled screening
- *No ESP services offered.
- *Lunch will still be available as a pick-up service for K-8 students.

Proposed start date for Phase 2: 9/23/2020

Phase 2

Full remote for all students except all students with special education needs and selected at-risk students. Students attending class will attend for 2.5 hours per day 4 days a week during this phase. Remote learning in these classrooms will be shifted to the afternoon. Families will be notified by the teacher regarding which students will need to attend.

- *No ESP services offered.
- *Lunch will still be available as a pick-up service for K-8 students.

1 week built into the plan to reassess the transitions and observe any COVID activity with students and staff.

Proposed start date for Phase 3: 10/5/2020

Phase 3

Grades PK -1 at the elementary / Grade 5 & 6 at the middle school returning as a hybrid A/B format. Group A will return on Monday/Wednesday while Group B attends on Tuesday/Thursday. Students will always attend the days of the week as assigned.

- *ESP services offered for days in attendance only.
- *Lunch will still be available on campus as well as a pick-up service for remote students.

Proposed start date for Phase 4: 10/12/2020

Phase 4

Grades 2 - 4 at the elementary / Grades 7 & 8 at the middle school returning as a hybrid A/B format. Group A will return on Monday/Wednesday while Group B attends on Tuesday/Thursday. Students will always attend the days of the week as assigned.

- *ESP services offered for days in attendance only.
- *Lunch will still be available on campus as well as a pick-up service for remote students.

General Notes Hybrid Notes:

- All students except those in Phase 1 will attend the A/B hybrid schedule as sent out by the district. District 115 will have all students returned and attending with a hybrid schedule at the start of quarter 2 on October 19 following the noted plan.
- If a holiday occurs on a scheduled attendance day during the week, the in-person day will be shifted to Friday. For example: if a holiday occurs on a Monday, Group A, will attend Wednesday and Friday. Example 2: If a holiday occurs on a Tuesday, Group B, will attend on Thursday and Friday.
- Parents should contact the principal's office if they have questions regarding changes between hybrid and remote plans.
- Hybrid scheduling will be based on last names as follows: Group A: A K and Group B: L Z
